Newfoundland court approves sale of 42 Catholic Church properties to help compensate victims of sexual abuse



ST. JOHN'S, N.L. — The Supreme Court of Newfoundland and Labrador approved the sale of 42 Roman Catholic Episcopal Corp. of St. John's properties on Monday to a value of more than \$20.6 million — a key step forward to finally being able to settle compensation claims with victims of sexual abuse dating back to the 1940s, '50s and '60s.

Twelve of the properties approved for sale are churches.

Nineteen properties did not receive acceptable bids during the tender process and will be offered up for sale again, along with 70 other church properties situated in the Burin and Avalon regions including churches, halls and rectories.

Lawyers for Episcopal Corp. also asked the court for another extension to continue with the work, which was unopposed by lawyers representing the victims or the monitor Ernst & Young.

Justice Garrett Handrigan granted the request shifting the end date to Dec. 9 of this year.

abuse of boys by certain members of the Irish Christian Brothers, the lay order that ran the Mount Cashel orphanage.

The ruling by the country's top court not to hear the appeal brought to an end to that stage of a 20-year legal battle.

Since the Supreme Court of Canada's decision more than 100 men have come forward intending to file claims against the Roman Catholic Episcopal Corp. of St. John's, and the claims are expected to exceed \$50 million.

A claims process is also underway before the courts.

The court process to approve the property sales on Monday was not without some drama.

Lawyers for the provincial government and the Newfoundland and Labrador English School District attended the hearing raising issues regarding the rights of government and the district to the Ecole Rocher-Du-Nord school property that is part of the properties approved for sale.

Issues surrounding other school properties that could be put up for sale are expected to be heard in November.

In March 2021, SaltWire Network was told by the school board that 34 public schools are still technically owned by the archdiocese of St. John's, but they are protected from being sold because they are still in use.

After the end of the denominational education system, Sect. 84 of the Schools Act, 1997 mandated agreements be reached with denominational authorities where the title to property used for educational purposes is held by government, the board said at that time.

Trustee documents indicated that "legal and factual uncertainty" will have to be sorted out before it is determined whether schools will be included in the tender sales package.

Lawyers for the victims, Ernst & Young, and the episcopal corporation agreed on Monday, however, that it was too late for government and the school district to make an objection to the Ecole Rocher-Du-Nord property sale at this stage. That objection should have been launched during the winter when the property was first listed as part of the tender package sale proposals.

Representative counsel Geoff Budden called the move "disrespectful."

"It's most disrespectful to the claimants to come forward at this late hour," Budden said. "Essentially, (try to) torpedo a process which enormous work has gone into.

"I realize government has duties to protect the public purse but surely that's not at the expense of treating survivors in this fashion."

Handrigan said he would grant the order approving the sale of the 42 properties "which will include Ecole Rocher-Du-Nord" but left it open for government and the school district to be able to make argument about the distribution of the proceeds from that particular sale at a later time.
